- is not a member of the Association
- is under 18 years of age
- is an employee of the Association or a close relative of an employee
- has been adjudged bankrupt, has granted a trust deed for or entered into an agreement with creditors or his/her estate has been sequestrated and has not been discharged
- has been convicted of an offence involving dishonesty which is not spent by virtue of the Rehabilitation of Offenders Act 1974 or an offence under the Charities and Trustee Investment (Scotland) Act 2005
- is a party to any legal proceedings in any Court of Law by or against the Association
- will be unable to attend Committee Meetings for a period of 12 months
- has been removed from the Committee of another registered social landlord within the previous 5 years
- has resigned from the Committee in the previous 5 years in circumstances where
 the resignation was submitted after the date of his/her receipt of notice of a
 special committee meeting convened to consider a resolution for his/her removal
 from the Committee in terms of Rule 44.5
- has been removed from the Committee in terms of Rule 44.4 or 44.5 within the last 5 years
- has been removed or suspended from a position of management or control of a charity under the provisions of the Law Reform (Miscellaneous Provisions) (Scotland) Act 1990 or the Charities and Trustee Investment (Scotland) Act 2005

- has been removed from the office of charity trustee or trustee for a charity by an order made by the Charity Commissioners for England and Wales or by Her Majestys High Court of Justice in England on the grounds of any misconduct in the administration of the charity for which he/she were responsible or to which he/she were privy, or which his/her conduct contributed to or facilitated
- a disqualification order or disqualification undertaking has been made against that person under the Company Directors Disqualification Act 1986 or the Company DirectorsqDisqualification (Northern Ireland) Order 2002 (which relate to power of a Court to prevent someone from being a director, liquidator or administrator of a company or a receiver or manager of company property or being involved in the promotion, formation or management of a company
- at an annual general meeting, he/she has served as a Committee Member for a continuous period in excess of 9 years and the Committee has not resolved to permit him/her to stand again or otherwise be nominated for re-election.
