We will use this feedback alongside our other tenant satisfaction survey work to shape the services we provide to you.

Common Allocations Policy Review

The Management Committee reviews policies on a regular basis to ensure that we operate in accordance with the law and best practice.

The Association works in partnership with the three other members of our common housing register: Calvay, Easthall and Lochfield.

The policy review ensures that we comply with updates to legislation and best practice. The main changes are detailed below:

- Amending the policy in line with new equalities
- Proof of identification will now be requested as well as proof of address:
- Foster carers are now formally included;
- The social and support category has been amended to include applicants who are moving due to employment in the area:
- Higher prioritisation for those applicants with no fixed
- Changes regarding streets scheduled for demolition;
- Increased points for those under-occupying their property;
- Widening the sources applicants can request medical information from to make it easier for applicants to obtain documentation to support their application;
- Formalising the appeals process.

Annual Assurance Statement

October 2022

The Management Committee of Gardeen Housing Association has taken external support from an independent governance consultant to develop a self-assurance document. This document was discussed at a Special Meeting on 20 October 2022 and the Management Committee has now been assured that the Ass complies with

- All relevant regulatory requirements set out in Section 3 of the Regulatory
- · All relevant standards and outcomes in the Scottish Social Housing Charter
- · All relevant legislative duties
- The standards of Governance and Financial Management
- Updated guidance on Business Planning resulting from COVID-19

The Management Committee confirms that there are no areas of material noncompliance. The Management Committee has identified a number of areas for improvement including equalities. We are collecting equalities information and we are discussing how we can adopt a human rights approach in our work. The Management Committee will continue to monitor the position regarding a potential rent freeze or cap.

The Management Committee shall review this statement on a regular basis and report any areas of material non-compliance to the Scottish Housing Regulator.

Gardeen Housing Association Savings: Value for Money

In the current economic crisis, the Management Committee are looking at every area of costs to ensure value for money. Cost savings have been achieved by:

- Reduced pension costs for staff
- Reduced staffing numbers from six to five we no longer employ a receptionist due to hybrid working
- Reduced heating, lighting and cleaning costs for office due to hybrid working
- Reduced postage costs by using text and email to communicate with tenants
- Reduced travelling costs by meeting on-line
- Sharing staff to provide an energy advisor and welfare rights advisor

The Management Committee will continue to examine all areas of expenditure and will consider further cost savings as we continue to provide a local friendly service to tenants.

MAINTENANCE

Electrical Safety Policy

The Association has a new Electrical Safety Policy. We are committed to ensure the safety of our residents with regards to electrical installations in our properties.

Maintenance Policy

Some suggested changes to the Association's Maintenance Policy are listed below. High inflation has meant our costs are going up so we need to cut back on some items which we may previously have carried out to assist tenants. Some examples are:

- No new floor covering to be provided in voids kitchens and bathrooms screed floor only;
- Vandalism costs for door entry to be recharged to tenants in close where possible. All tenants in close to be lettered with copy invoice(s);
- No decoration to be provided after water leaks;
- Doorbells are a tenant responsibility;
- Toilet seats are a tenant responsibility;
- Replacing light bulbs/strip light starters are a tenant responsibility.



Condensation

Moisture in the air forms condensation when it comes into contact with cold surfaces such as windows. There are some simple steps you can take to minimise a build-up of condensation in your home:-

- Improve ventilation by opening windows when cooking, bathing or drying clothes;
- If possible, hang clothes outside to dry, rather than on radiators;
- Regularly clear your windows of condensation so it doesn't cause damage or develop into mould;
- Ensure your home is sufficiently heated;
- Use extractor fans where available;
- will arrange to visit you.

Gritting

Glasgow City Council is responsible for gritting the roads and pavements. To report a gritting issue to them please call them on 0800 373 635 or 0141 276 7000.

If you have your own garden or a shared garden as part of a cottage flat or four in a block then you are responsible for gritting this area.

Gardeen regularly monitors the level of salt in the grit bins in our area but if a refill is needed then please go online to Glasgow City Council's website or call the numbers above.

You are welcome to use the grit bins that have been filled for the winter. This can help you and your neighbours to get out and about in icy weather.

Rent Payments

Christmas can be a costly time of year and there is added pressure this year with rising energy prices and the cost of living crisis.

Rent payments must still be paid during the festive period but if you are experiencing difficulty paying your rent or meeting other household bills, then please contact us. Discussing any financial difficulties sooner, rather than later, will allow us to work with you to resolve matters.

Our welfare rights service (available every Tuesday) can also assist you to ensure you are receiving the welfare benefits you are entitled to and provide you with confidential advice and support for any money or debt worries you may have.

Our office will be closed from 1.00pm on 23 December 2022 and will reopen at 9.30am on Thursday 5 January 2023.

You can pay by bank transfer; by Direct Debit; using your Allpay card or online using www.allpayments.net.

Please contact Lyndsay or John at our office in the first instance, if you wish to discuss any financial matter. We are here to help.





You will receive some information from the Association in January 2023 on the proposed rent increase for 2023-2024.

By law, we must consult with you on the proposals.

The Management Committee are made up of Gardeen residents and they look at the budget for 2023-2024 and the plans that have been made to ensure that your home is maintained and that you continue to receive a quality service.

All the costs for the Association are considered such as staffing costs, training costs, repairs and maintenance costs and this helps us to budget for next year.

The Management Committee also look at the long term financial plans for the Association to check that we have enough funds for our future proposals.

The Scottish Government introduced a rent freeze until 31 March 2023 because of the cost of living crisis.

A further decision will be made by the Scottish Government by the 14 January 2023 to extend this rent freeze, introduce a rent cap or end the rent freeze.

We want to ensure that rents remain affordable but we must also ensure that we are covering our costs so that we can continue to carry out planned maintenance works such as new kitchens and windows.


